 - 3. Contributions to Optometry (10 points)**
 - Actively contributes to the advancement of optometry through education, research, policy, or innovation.
 - May include published research, program development, or service expansion initiatives.
 - 4. Community Involvement and Public Service (10 points)**
 - Participates in community outreach, public health initiatives, or volunteer services related to eye care.
 - Raises awareness about eye health and improves access to care for underserved populations.
 - 5. Ethics and Professionalism (10 points)**
